# Dear Michael Ding:

This letter is in response to your Freedom of Information Act (FOIA) request dated August 9, 2022 for access to Biden Vice Presidential records pertaining to Vice President Biden's records regarding official travel and White House visits by Hunter Biden and James Biden. Your request was received by the Archival Operations Division on August 9, 2022. FOIA requests for Biden Vice Presidential records are processed and reviewed for access under provisions of the 1978 Presidential Records Act, as amended (PRA) (44 U.S.C. §§ 2201-2209), which incorporates the Freedom of Information Act (5 U.S.C. § 552) in substantial part.

We have completed processing 3 Biden Vice Presidential email messages related to this request. Of this total, 1 email message in whole and 1 email message in part have been exempted from release in compliance with the restrictions of the PRA and applicable FOIA exemptions, which specify what material may be released to the public. All necessary steps were taken to segregate and release non-exempt information. The 1 email message in whole and 1 email message in part restricted from access are listed along with the exemption categories below. Some email messages may be restricted under more than one category.

P5 – 1 email message P6/(b)(6) –1 email message

A list of the PRA restrictions and FOIA exemptions, as well as a copy of the finding aid that describes the processed material are attached.

If you are unsatisfied with this response, you have the right to file an administrative appeal of the withholding decisions under the exemption categories listed at 44 U.S.C. § 2204(a). The appeal must be submitted in writing to the Director, Archival Operations Division, National Archives and

Records Administration, 700 Pennsylvania Avenue, NW, Room G-7, Washington, DC 20408-0001. You should also include a copy of your original request and our denial. Both your appeal letter and the envelope should be clearly marked "PRA/FOIA Appeal." To be considered timely, your appeal must be postmarked or electronically submitted within 90 calendar days from the date of this letter

We have also completed our review and corresponding PRA notification period, of 8 Biden Vice Presidential email messages addressed in your August 2024 appeal. Of this total, 7 email messages in whole and 1 email message in part remain exempted from release in compliance with the restrictions of the PRA and applicable FOIA exemptions, which specify what material may be released to the public. All necessary steps were taken to segregate and release non-exempt information. The 7 email messages in whole and 1 email message in part restricted from access are listed along with the exemption categories below. Some email messages may be restricted under more than one category.

P5 – 7 email messages P6/(b)(6) –5 email messages

The remaining 1 email message in part is available. # **PRA Restrictions and FOIA Exemptions**

# Presidential Records Act - [44 U.S.C. §2204(a)]

- P1 National security classified information [(a)(1) of the PRA]
- P2 Relating to the appointment to Federal office [(a)(2) of the PRA]
- P3 Release would violate a Federal statute [(a)(3) of the PRA]
- P4 Release would disclose trade secrets or confidential commercial or financial information [(a)(4) of the PRA]
- P5 Release would disclose confidential advice between the President and his advisors, or between such advisors [(a)(5) of the PRA]

P6 Release would constitute a clearly unwarranted invasion of personal privacy [(a)(6) of the PRA]

PRM Personal record misfile defined in accordance with 44 U.S.C. 2201(3)

### **Scope and Content**

The materials in this series are selective, not necessarily all-inclusive, body of records responsive to the topic of FOIA case 2022-0120-F. The researcher submitted a Freedom of Information Act (FOIA) request for records for Biden Vice Presidential records concerning White House visits and official travel with his son Hunter Biden and brother James (Jim) Biden and narrowed their request to specific terms. This FOIA segment includes one email message originally processed in response to the following FOIA case segment: 2022-0121-F[6].

This series consists of an email message dated November 13, 2013 from Kathy Chung to Katie Dodge with Hunter Biden carbon copied regarding Hunter and Finnegan Biden's upcoming travel with Vice President Biden to China and Japan.

## **System of Arrangement**

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date. The following is a list of the SRLs saved and processed in response to FOIA 2022-120-F[4]:
